The Photographic Archive of Fondazione Centro di Documentazione Ebraica Contemporanea Onlus {CDEC} together AEPJ European Association for the Preservation and Promotion of Jewish Culture and Heritage, launch the 5.th edition of the **European Photographic Contest** on the theme

Jewish heritage & nature

A prize ceremony and the exhibition of finalist photographs will be held in Milan on September 29, 2013 during the European Day of Jewish Culture .

CONTEST RULES

(these rules are based on the Italian law)

1. The theme of the Contest is: "JEWISH HERITAGE & NATURE". Photographs will illustrate the theme; they will include jewish subjects: the symbolic meaning of nature in holidays and celebrations, connections with Israel land, agriculture, youth camps, etc. Contest has two sections:

A) AUTHOR PHOTOGRAPHS (original photographs produced by participants), and
B) PHOTOGRAPHS FROM THE DRAWER (family photographs on the contest theme)
2. The Contest is open to all. Participation is free.
3. Participants must fill out and sign the Participation Form that can be downloaded or filled online at
[www.cdec.it/concorso fotografico 2013.asp](http://www.cdec.it/concorso_fotografico_2013.asp).
4. Each participant can send up to ten photographs for each contest section. Photographs shall be submitted in digital format or as prints, and may be in black-and-white and/or color. Digital photographs must be submitted in JPG or TIF format with minimum resolution of 300 dpi.
5. Each photograph will be accompanied by

Section A

- First and last name of participant-author; telephone, address, email address
- Title, date and location of the photography

Section B

- First and last name of participant; telephone, address, email address
- First and last name of the author; title, date and location of the photograph if available

6. Participants may submit photographs and participation form

Receipt of materials will be confirmed via email.

7. The deadline for submitting photographs is **midnight, August 31, 2013.**

8. Participants are responsible for the photography content, and hold all rights for photography use.

9. Participants shall hold CDEC harmless against any and all liabilities, claims and suits deriving from the use, dissemination and/or publication of the photographs submitted to the Contest.

10. CDEC will communicate the results of the Contest exclusively via email.

11. The Jury is named by CDEC and is composed by experts of communication, art and photography. All Jury decisions are final and may not be challenged

12. Among all participating photographs, the jury will select finalist photographs, that will be on exhibit for the European Day of Jewish Culture on September 29, 2013 in Milan. The winning photographer of section A (Author photograph) will receive the Contest Prize of €350. Winner of section B (photographs from the drawer) will receive a special mention.

13. By submitting photographs, participants grant CDEC the right to use, disseminate and publish said photographs at no charge.

14. The photographs will be kept in the CDEC Photography Archive and may be used by CDEC at no charge for the purposes laid out in the CDEC by-laws.

15. Pursuant to Article 13 of Legislative Decree 196/2003 (D.Lgs. 196/2003),

the Italian law regarding protection of personal data, CDEC notifies participants as follows:

- a. Participants shall provide personal data as indicated at Point 8 above.
- b. Personal data will be processed for the following purposes:
 - i. participation in the Contest and awarding of the prize to the winner in accordance with Contest Rules;
 - ii. historical research and educational activities pursuant to CDEC by-laws.
- c. Data will be processed in electronic form or as printed media, may be organized into databases or archives, and may be communicated, as necessary, via mail, telephone, email or any other similar means.
- d. Personal data will be made known to CDEC personnel, who, appointed as Data Controller and/or Data Processor in accordance with the applicable law, will process said data for the purposes indicated above. Personal data may also be published on the website www.cdec.it.
- e. Submission of personal data and their processing for the purposes indicated in Point 15b) is optional. However, in reference to Point 15b), said personal data are strictly necessary for participation in the Contest and failure to provide them and/or to consent to their processing, as well as any errors in the data themselves, will make participation in the Contest impossible.
- f. Participants may exercise at any time their rights pursuant to Article 7 of D.Lgs. 196/2003.
