

RULES FOR PHOTOGRAPHY CONTEST

Judaism in the age of new media

New tools of communication, representation and exchange

IMPORTANT: Please note that these rules are based on Italian law

1. The Contest is open to all.
 2. Participation in the Contest is free of charge. Prospective participants must fill out the participation form which can be downloaded or filled online at http://www.cdec.it/concorso_fotografico_2011.asp
 3. Participants may submit photographs created by themselves or by others.
 4. Participants are responsible for the content of their entries and may only submit works that they are legally entitled to use for such purposes. CDEC is relieved of any liability deriving from the publication of said works.
 5. The photographs shall be submitted in digital format or as prints, and may be in black-and-white and/or color. Digital photographs must be submitted in JPG or TIF format with minimum resolution of 300 dpi.
 6. Each photograph must be accompanied by:
 - participant's name (last name, first name), telephone number, mailing address, email address;
 - photographer's name (last name, first name), if different from participant;
 - title of the photograph;
 - caption, if applicable;
 - year and place where photograph was taken.
 7. Participants may submit
 - photographs as follows:

- Receipt of materials will be confirmed via email.
8. The deadline for submitting photographs is **midnight, May 31, 2001**.
 9. CDEC will communicate the results of the Contest exclusively via email.
 10. All Jury decisions are final and may not be challenged.

11. By submitting photographs, participants grant CDEC the right to use, disseminate and publish said photographs at no charge.
12. The photographs will be kept in the CDEC Photography Archive and may be used by CDEC at no charge for the purposes laid out in the CDEC by-laws.
13. Participants shall hold CDEC harmless against any and all liabilities, claims and suits deriving from the use, dissemination and/or publication of the photographs submitted to the Contest.
14. Pursuant to Article 13 of Legislative Decree 196/2003 (D.Lgs. 196/2003), the Italian law regarding protection of personal data, CDEC notifies participants as follows:
 - a. Participants shall provide personal data as indicated at Point 6 above.
 - b. Personal data will be processed for the following purposes:
 - i. participation in the Contest and awarding of the prize to the winner in accordance with Contest Rules;
 - ii. historical research and educational activities pursuant to CDEC by-laws.
 - c. Data will be processed in electronic form or as printed media, may be organized into databases or archives, and may be communicated, as necessary, via mail, telephone, email or any other similar means.
 - d. Personal data will be made known to CDEC personnel, who, appointed as Data Controller and/or Data Processor in accordance with the applicable law, will process said data for the purposes indicated above. Personal data may also be published on the website www.cdec.it.
 - e. Submission of personal data and their processing for the purposes indicated in Point 14 b) is optional. However, in reference to Point 14 b) letter i, said personal data are strictly necessary for participation in the Contest and failure to provide them and/or to consent to their processing, as well as any errors in the data themselves, will make participation in the Contest impossible.
 - f. Participants may exercise at any time their rights pursuant to Article 7 of D.Lgs. 196/2003.
